CROSSPOINTE CHURCH SKATEBOARD AND IN-LINE SKATE MINISTRY ACKNOWLEDGMENT / AGREEMENT / WAIVER / ASSUMPTION OF RISK TO INDEMNIFY FOR MINORS AND ADULT PARTICIPANTS

I, the undersigned (hereinafter referred to as the "Undersigned"), do agree to indemnify CrossPointe Church (property buildings and grounds hereinafter referred to as "CPC") upon the reception of this ministry acknowledgment/agreement/waiver/assumption of risk agreement to indemnify (hereinafter referred to as the "Agreement") and hereby grant permission to the above named person to participate (hereinafter referred to as "Participant") in the Skateboard/In-line Skate Ministry of CPC (hereinafter referred to as "RPM") subject to the following conditions, requirements and Agreement:

1. The Undersigned (parent/legal guardian of the above named Participant or the above named adult Participant) understands, acknowledges, and agrees that this Agreement applies whether the participant is an observer, a bystander, or an active participant, whether the activity is at the above stated premises, adjacent CPC properties, or on an outing, including traveling to or from such activities.
2. I understand that at all times the Participant must obey and show proper respect for all the RPM volunteers, CPC pastors, staff, interns (hereinafter referred to as "Staff"), and all the RPM rules during RPM functions.
3. The Undersigned understands, acknowledges, and agrees that skateboarding and in-line skating are extremely dangerous sports and may/can result in personal property damage, bodily injury, and/or even death, and is fully aware of these and other risks and hazards inherent to such activities and hereby enrolls voluntarily, without duress, the Participant, knowing and accepting as-is the present condition of RPM's equipment, facilities, and property (including helmets, rails, ramps, etc.) with full knowledge that the said condition may become more hazardous and increasingly dangerous at any time while he/she is involved in/with RPM.
4. The Undersigned hereby voluntarily assumes all risk of loss, damage, injury, or death that may be sustained by the Participant and any damage to or loss of his/her property while in RPM and understands that various degrees of experience and skill are required for the different skating surfaces and agrees that it will be in the Participant's sole discretionary judgment as to what he/she will attempt to safely skate. **Helmets are required at all times while skating !!!**
5. In consideration, and upon the reception of this RPM Agreement, the Undersigned hereby releases CPC on behalf of the above named Participant, his/her heirs assigns, and legal representatives from any and all liability for personal injuries or property damage/loss or death arising out of the Participant's involvement, whether or not the said injuries or damages were caused by the negligent care of the facilities, ramps, equipment, or by the RPM Staff. The Participant and Undersigned agree never to sue any RPM or CPC Staff or entities in connection with any and all damages, losses, claims, demands, rights, actions, and causes of action of whatever nature whether injuries, death, or damages/losses to the property of the Participant.
6. The Undersigned agrees for himself/herself, and for his/her heirs and legal representatives to indemnify RPM, its Staff, CPC, its paid Staff, volunteers, and attenders, against, and to save and hold harmless from any and all damages, actions, causes of action, claims, judgments, costs of litigation and attorney's fees, which may in any way and at any time result from the Participant's involvement in RPM.
7. CPC may immediately revoke this Agreement for any violations of any of its terms.
8. I warrant to CPC that all the information given on this form is true, current, and accurate. Updating necessary information is the responsibility of the Undersigned.
9. I, as the adult Participant have read, understand and consent to the terms above and to the minor becoming a voluntary Participant.
